Gentlemen:

In case of a discrepancy between the words and figures, the words (unless obviously incorrect) shall prevail. The undersigned bidder has checked carefully all words and figures on the above Bid Schedule(s) and understands that the District will not be responsible for any errors or omissions on the part of the bidder in making up his bid.

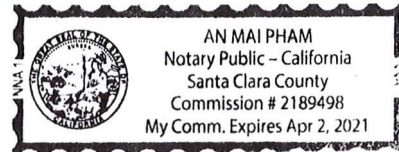
