## MINUTES OF THE REGULAR BOARD MEETING OF THE BOARD OF DIRECTORS OF THE SANTA MARIA PUBLIC AIRPORT DISTRICT HELD MARCH 24, 2022

The Board of Directors of the Santa Maria Public Airport District held a Regular Meeting via a virtual meeting at 7:00 p.m. Present were Directors Engel, Brown, Rafferty, Adams, and Baskett. General Manager Hastert, Manager of Finance & Administration Reade, and District Counsel George.

- 1. MINUTES OF THE REGULAR MEETING HELD March 10, 2022. Director Rafferty made a Motion to approve the minutes of the regular meeting held March 10, 2022. Director Baskett Seconded and it was carried by the following roll call vote. Directors Engel, Brown, Rafferty, Adams, and Baskett voted "Yes".
- 2. COMMITTEE REPORT(S):
  - a) AVIATION SUPPORT & PLANNING (Standing or Ad Hoc) No meeting scheduled.
  - b) ADMINISTRATION & FINANCIAL (Standing or Ad Hoc) No meeting scheduled.

- 3. GENERAL MANAGER'S REPORT. Mr. Hastert updated the board on recent meetings he attended which include the AirFest committee, the Water Board regarding the PFAS Investigation and the CAC. A Fish & Wildlife meeting is scheduled. Bids have been opened for the upcoming Taxiway Rehabilitation project. Planes of Fame started kickoff on the ground and Mr. Hastert will be attending the Mead & Hunt Air Service Development conference next week.
- 4. The Manager of Finance & Administration presented the Demand Register to the Board for review and approval.
  - a) Demand Register. The Demand Register, covering warrants 070030 through 070063 in the amount of \$131,915.57 was recommended for approval as presented. Director Baskett made a Motion to accept the Demand Register as presented. Director Rafferty Seconded and it was carried by the following roll call vote. Directors Engel, Brown, Rafferty, Adams, and Baskett voted "Yes".

- 9. Authorization for the General Manager to execute the Amendment of Listing Agreement between the District and Tom Ross Realty. This item was tabled until a future meeting.
- 10. Authorization for tuition reimbursement for one staff member. Director Rafferty made a Motion to approve. Director Adams Seconded and it was carried by the following roll call vote. Directors Engel, Brown, Rafferty, Adams, and Baskett voted "Yes".

One reportable action. Item 11-c is related to existing litigation filed by Director Baskett v. SMPAD. The action was filed without the Government Code Claim. Subsequent to a motion to dismiss filed by Counsel for the District, the District did receive a Government Code Claim outlining damages and claims reflected in his existing litigation. In Closed Session, the Board took action to reject the claim.

12. DIRECTORS' COMMENTS: Directors Engel, Brown, Rafferty, and Adams had no comment.

Director Baskett asked for an update on Customs. He reiterated his thoughts on the threat of drones. He mentioned he would like to see the pavement fixed near the maintenance shop and the main hangar.

13. ADJOURNMENT. President Engel asked for a Motion to adjourn to a Regular Meeting to be held on April 14, 2022, at 7:00 p.m. at the regular meeting place. ### **RESOLUTION NO. 911**

## A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SANTA MARIA PUBLIC AIRPORT DISTRICT SUPPORTING THE RETURN OF THE CENTRAL COAST AIRFEST FOR 2022.

WHEREAS, the Santa Maria Public Airport District (SMPAD) has hosted two award winning Air Shows in 2018 and 2019 now known as the Central Coast AirFest (Air Show); and,

WHEREAS, due to the COVID-19 pandemic, the Central Coast AirFest was cancelled in both 2020 and 2021; and,

WHEREAS, the Board of Directors of the Santa Maria Public Airport District recognize the value of hosting the Central Coast AirFest as a community event to promote aviation; and,

WHEREAS, The Planes of Fame Air Museum has executed a lease to expand to the Santa Maria Airport; and,

WHEREAS, the Planes of Fame Air Museum has hosted several successful air shows and has agreed to partner with the Santa Maria Public Airport District including aircraft support, marketing, and sponsorship; and,

WHEREAS, COVID-19 restrictions and vendor availability remain a challenge requiring the air show committee to be nimble and able to react quickly to opportunities that will ensure a successful show; and,

WHEREAS, the Board of Directors continue to seek a show that provides excess funds generated from the Central Coast AirFest, and that those funds be used exclusively for seed money for the next Central Coast AirFest, direct support for 501(c)(3) non-profit groups volunteering to assist during the event, aviation scholarships, and other community support as approved by the Board of Directors, seek to profit from the work of volunteers or sponsors of the event;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Santa Maria Public Airport District:

- 1. The General Manager of the Santa Maria Public Airport District is authorized to execute contracts for expenditures up to \$75,000 each for performers, safety and sanitation, hotel, and event planning.
- 2. The Aviation Support and Planning Committee of the Santa Maria Public Airport District Board provide oversight of the contract expenditures and work to establish guidelines and direction for a sub-committee of volunteers directly representing the Santa Maria Public Airport District Board, which has been formed to plan and manage the Central Coast AirFest for the enjoyment of the Central Coast community, advancement of education and interest in aviation, and aviation careers, showcase the facilities and operations of the Santa Maria Airport.

- 3. Planes of Fame Air Museum is officially recognized as a partner in the Central Coast AirFest and qualified as one of the 501(c)(3) non-profit organizations eligible for direct support with a portion of any excess funds.
- 4. The Marketing Committee of the Santa Maria Public Airport District Board provide a recommendation regarding sponsorship to cover operational and maintenance support by the Santa Maria Public Airport District previously set in the amount of \$15,000 plus in-kind services;
