#### **RESOLUTION NO. 935**

# A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SANTA MARIA PUBLIC AIRPORT DISTRICT CLARIFYING AUTHORITY OF DIRECTOR DAVID BASKETT IN HIS INDIVIDUAL CAPACITY AS A DIRECTOR OF THE DISTRICT

- WHEREAS, the Santa Maria Public Airport District (the "District") is an airport district duly formed and existing under the California Public Utilities Code ("PUC") section 22001 et. seq; and
- **WHEREAS,** PUC section 22401 provides that, "A board of five directors is the governing body of the district," and PUC section 22551 further provides that, "...the powers of the district shall be exercised by the board"; and
- **WHEREAS**, the rules and regulations specifically governing the District are contained in the Official Administrative Code of the Santa Maria Public Airport District ("Administrative Code") as amended from time to time by the District Board of Directors; and
- **WHEREAS**, paragraph (a) of Section 11 of Article I of the Administrative Code provides that: "All action of the District shall be taken by the board. No individual board member shall represent a policy as the District's policy, unless said policy has been determined by the board"; and
- **WHEREAS**, paragraph (b) of Section 11 of Article I of the Administrative Code continues: "The board of directors, acting as a board, shall be the policymakers of the District, establishing policy after receiving necessary information from staff and other persons as deemed necessary"; and
- **WHEREAS**, the District is insured as a member of the Special District Risk Management Authority ("SDRMA"); and
- **WHEREAS,** on May 24, 2024, the District received notice from SDRMA, which is attached hereto as Exhibit "A," stating that, effective July 1, 2024, the Liability Coverage Agreement for the District will exclude all claims or suits "caused by or resulting from any act or failure to act of David Baskett"; and
- **WHEREAS**, on May 24, 2024, the District received further notice from SDRMA, which is attached hereto as Exhibit "B," that, effective July 1, 2024, "the Board Members/Directors Coverage Agreement does not apply to any liability of David Baskett for Personal Injury for any claim or suit arising out of an Occurrence"; and
- **WHEREAS**, Director David Baskett ("Director Baskett") currently serves as a member of the District Board of Directors; and
- **WHEREAS**, maintenance of adequate insurance coverage is critical to the continued management, operation, and success of the District; and
- **WHEREAS**, the coverage exclusion necessitates that the District Board of Directors clarify the authority of Director Baskett and protect the District from unnecessary risk created by the SDRMA coverage exclusion endorsement; and

**WHEREAS**, the District Board of Directors desires to protect the District from that risk and clarify the role of Director Baskett in the governance of the Airport and the District.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Santa Maria Public Airport District, that the Board of Directors reaffirms the limitation contained in state law and District Administrative Code, as described in section 11 of Article I, that, "[all] action of the District shall be taken by the board. No individual board member shall represent a policy as the District's policy, unless said policy has been determined by the board."

**BE IT FURTHER RESOLVED** that Director Baskett serves only as an individual member of the District Board of Directors and as such has no independent authority delegated to him under state law, under the Administrative Code, or by this body to act or speak on behalf of the District or its Board of Directors.

**BE IT FURTHER RESOLVED** that, as of the date of this resolution, Director Baskett does not serve as an officer of the District Board of Directors, and as such has no separate authority delegated to him under state law, under the Administrative Code, or by this body to act or speak on behalf of the District or its Board of Directors.

**BE IT FUTHER RESOLVED** that, for the foregoing reasons, Director Baskett is not a legal agent or officer of the District and does not have any delegated authority to act or speak on behalf of the District or its Board of Directors; and the District Board of Directors hereby repudiates any act taken by Director Baskett after the date of this resolution representing any such authority.

**BE IT FURTHER RESOLVED** that District staff are hereby directed and authorized to take any reasonable and lawful steps to protect the interests of the District necessitated by the coverage exclusion described in this resolution.

**BE IT FURTHER RESOLVED** that the Board of Directors does not desire to limit the right of Director Baskett to lawfully participate as an individual member of the District Board of Directors, such as the right to attend meetings and vote on matters that come properly before the board, and any other rights of office that may be specified by state law; this resolution shall not be interpreted as infringing on those rights of office, and to the extent that any provision of this resolution is deemed by a court of law as infringing on those rights, that provision shall be severable without affecting the validity of any other provision of this resolution.
