Subject: Airfield Lighting Regulators Emergency Purchase Ratification

Recommendation:

Staff recommends the Board of Directors ratify the emergency purchase and installation of two airfield lighting regulators.

Discussion:

On September 12, 2022 General Manager Hastert was notified by the operations and maintenance manager that after two weeks of high temperatures, one regulator controlling a taxiway lighting circuit had failed and that despite current functionality, the regulator controlling the runway lighting circuit was showing similar signs of imminent failure as well.

In response, General Manager Hastert authorized emergency work to switch the taxiway circuit to an alternate circuit as a temporary solution. Upon receiving quotes from the two regulator manufacturers meeting FAA spec and sizing requirements, two regulators were ordered as replacement.

The emergency purchase in an amount above the prescribed limit set for staff suggests that the Board of Directors ratify the acquisition by voting to approve the expenditure. Cost for both generators including installation is \$46,710.32, with documentation attached.

SUBJECT: Airport Lighting

The last two weeks of high temperatures have created an issue with the Airport lighting system. The ADB Regulator for Circuit E had an internal circuit failure that melted the windings, shorting out the regulator. The ADB regulator for RWY 12/30 is experiencing the same issue although it is still functioning. We had Earthbound electric look at both regulators the following day. Jason from Earthbound has suggested that both regulators should be replaced.

I have attached the quote and PO for the regulators and installation labor.

We have sought replacement through the Airport Lighting Company (ALC). In 2020 we replaced two regulators on Circuit A and D and their quotes were the lowest. Therefore, we would like to purchase both regulators for \$35819.82 + tax.

Ground shipping with ALC is free.

In addition, the quote for labor from Earthbound is \$10,890.50

Subject: Litigation Costs Related to Matters Regarding Director Baskett

On September 22, 2022, staff presented the Board of Directors with a Budget Deviation containing an overage in legal expenses attributed to several items including costs related to litigation involving Director Baskett. During discussion for this item, staff was directed to work with District Counsel to provide a report detailing costs associated with legal fees related to Director Baskett regarding litigation during his time as an Airport Board Member.

Please find the information below as provided by District Counsel:

Staff was also asked to estimate staff time spent dealing with these issues, which unfortunately is difficult to ascertain on such short notice and due to the transition of the former general manager. While Mr. Hastert did not have adequate time to search through several years of information, he remains available to assist with future requests regarding this matter. While Mr. Hastert was unable to determine the exact number of hours spent on Director Baskett related legal issues, he expressed frustration with the constant distraction from regular airport operational needs and development projects and felt that Director Baskett's repeated threats of deposition present an ongoing effort to intimidate him.

These distractions include public records requests from Mr. Baskett for items related to his litigation handled outside of the legal process, preparation for updates to the Board and Counsel regarding Director Baskett legal issues, texts and calls after working hours with legal demands that did not follow proper legal processes, and constant communications sent with baseless allegations copied to individuals not directly involved in these matters.

All this despite District Counsel's urging that Director Baskett follow proper procedures and refrain from further direct contact with Mr. Hastert.
