He doesn't see a way where it benefits either and doesn't want to incur any civil and or criminal penalties for a gift of public funds. He won't be taking any further actions as he sees this as a gift of public funds. He thanked Mr. Baskett for his entrepreneurship but would like to move forward on this matter.

Director Baskett enjoyed the lease software presentation. He then rebutted the comments made by Director Adams stating it was not a gift of funds for his personal use. He was given the money to start an airline. He stated he could file for bankruptcy but has chosen not to. He has negotiated away his debt with other entities including with the City. He understands the concerns of Director Adams, but he feels this was a public service and a public airline bringing additional service to the airport at the communities' request. He would like clarification from District Counsel on whether or not this would be considered a gift of public funds.

As you are aware, our Jokela grazing lease currently has a termination date of October 31st. I am contacting you to request an immensely needed extension to this termination date. We currently have been able to remove and cleanup approximately 80% from the property but are running out of time now. I am still working on a couple leads for a new lease to move the animals and equipment to, but the process is still in the works and has not been completely worked out yet. Without having another lease nailed down we are having difficulty being able to transfer the animals and equipment to another location. Another hurdle that is coming up is my dad is scheduled to have surgery this week which is going to be another setback for us. I am not trying to extend this long term or keep pushing this back by any means, but it would be very helpful if it was at all possible to get this termination date moved to the end of the year. If the date was extended to the end of the year, we are still going to be shooting for being out as soon as another lease gets worked out, which could very well be before even the end of November. Like I mentioned before, a lot of progress has already been made on removal and we are not trying to look for anything to keep stretching this lease out long term. Ideally for us would be the end of the year date but for us to still shoot for being out before the end of November.
