MINUTES OF THE REGULAR BOARD
MEETING OF THE BOARD OF DIRECTORS
OF THE SANTA MARIA PUBLIC AIRPORT
DISTRICT HELD DECEMBER 11, 2025

The Board of Directors of the Santa Maria Public Airport District held a Regular Meeting at the regular meeting place at 6:00 p.m. Present were Directors Moreno, Brown, Guy, and Clayton. General Manager, Pehl, and District Counsel Steele. Director Adams was absent.

1. President's Year in Review. President Moreno reflected on his three-year term serving as President of the Board and outlined several accomplishments during his tenure. These included settling multiple lawsuits with state and federal agencies, adding solar infrastructure, completing taxiway improvements, rehabilitating the runway, making improvements to the fire station, rebuilding relationships with local, state, and federal authorities, securing twice-daily air service to a major hub, and modernizing several District processes.

He stated that the foundation has been rebuilt for long-term financial prosperity and growth opportunities for the City and the region and expressed immense pride in serving his hometown in a meaningful and measurable way.

President Moreno reported that he recently moved out of his elected district and is therefore no longer eligible to serve on the Board. He announced his official resignation, effective following the meeting, and thanked the Board and staff for the opportunity to serve, as well as for the lessons learned, connections made, and friendships formed during his tenure.

Director Brown made a Motion to set the following slate nomination to take effect at the first meeting in January:

Director Brown for President, Director Adams for Vice President, Director Guy for Secretary and Director Clayton for Vice Secretary. The appointed Officer will take the position of Director once that person is selected.

Director Clayton Seconded, and it was carried by the following roll call vote. Directors Moreno, Brown, Guy, and Clayton voted "Yes".

He also discussed plans for Customs marketing efforts, which will include attendance at NBAA conferences in the first quarter of 2026.

He wished Director Moreno the best in his future endeavors.

Director Guy stated that he was impressed when he first met Director Moreno during his own campaign for office, noting Director Moreno's deep understanding of both the community and the airport. He expressed that while it is sad to see Director Moreno leave the Board, he is excited to see what he does next and offered his continued support for any future endeavors.

Director Moreno stated that it has been an absolute honor to serve on the Board. He expressed his appreciation for everything he has learned during his tenure and thanked his fellow Board members and staff for their support.

15. Adjournment: President Moreno asked for a Motion to adjourn to a Regular Meeting to be held on January 8, 2026, at the regular meeting place. Director Brown made that Motion, President Moreno Seconded, and it was carried by a 4-0 vote.

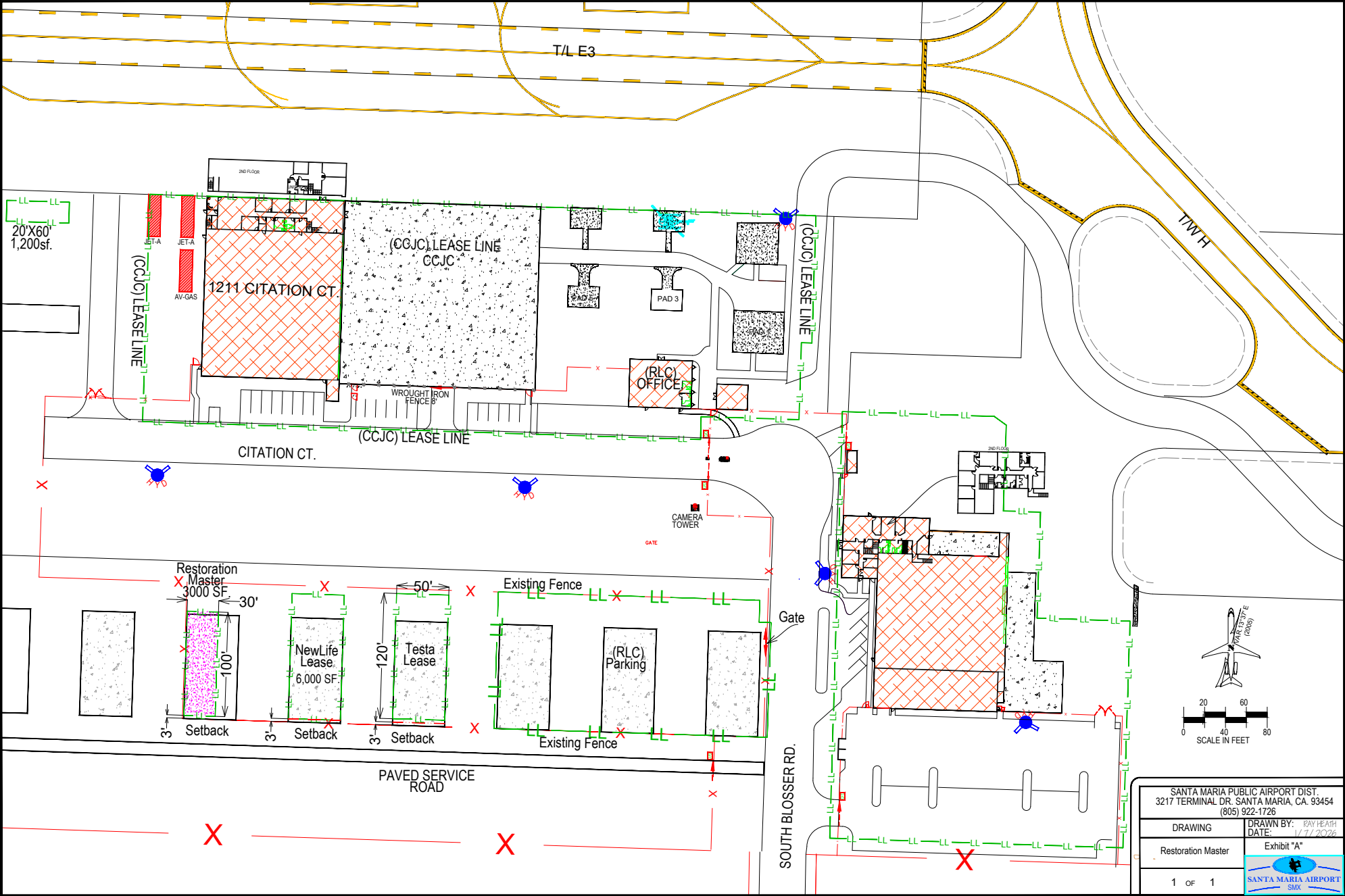

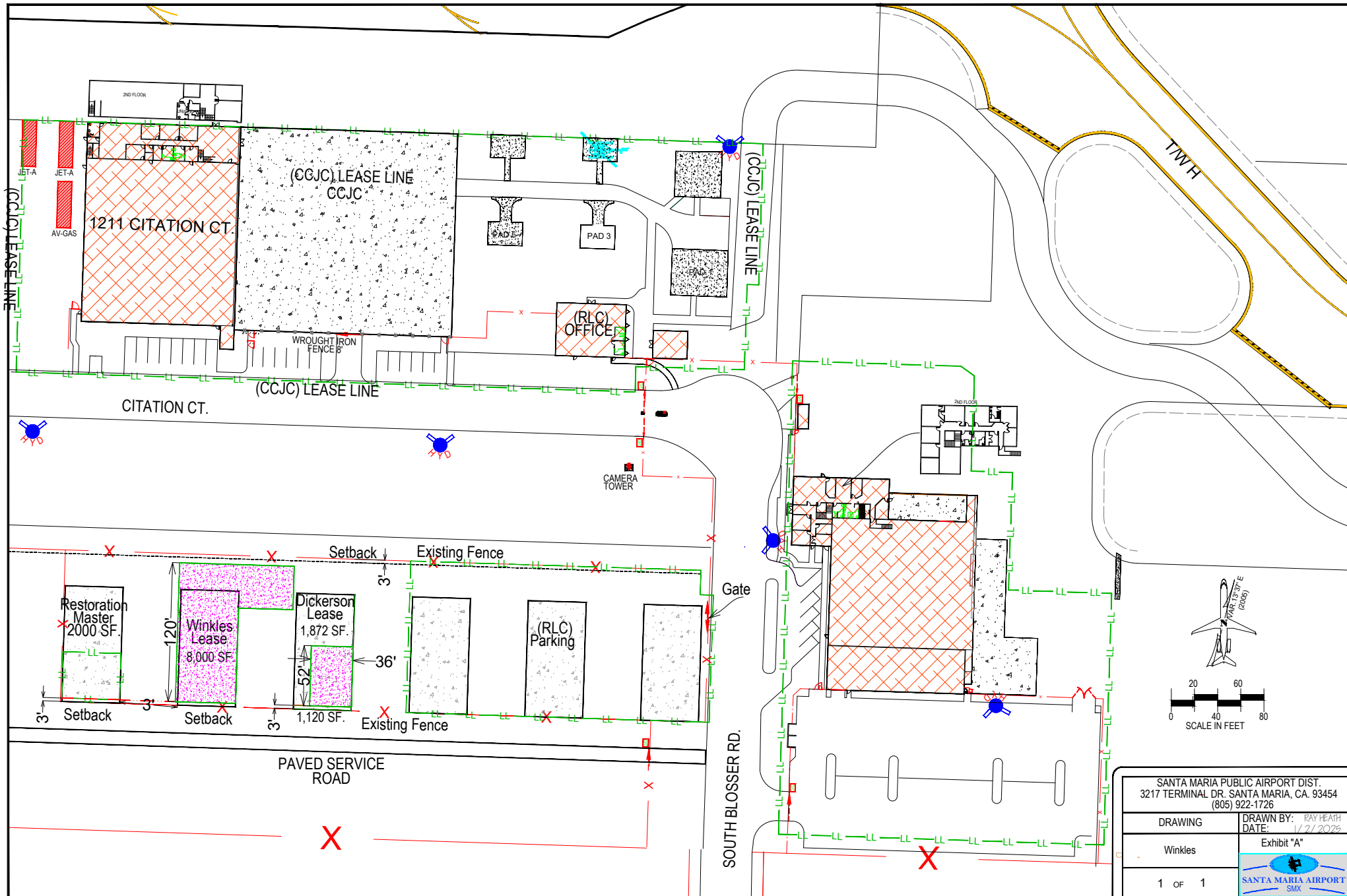

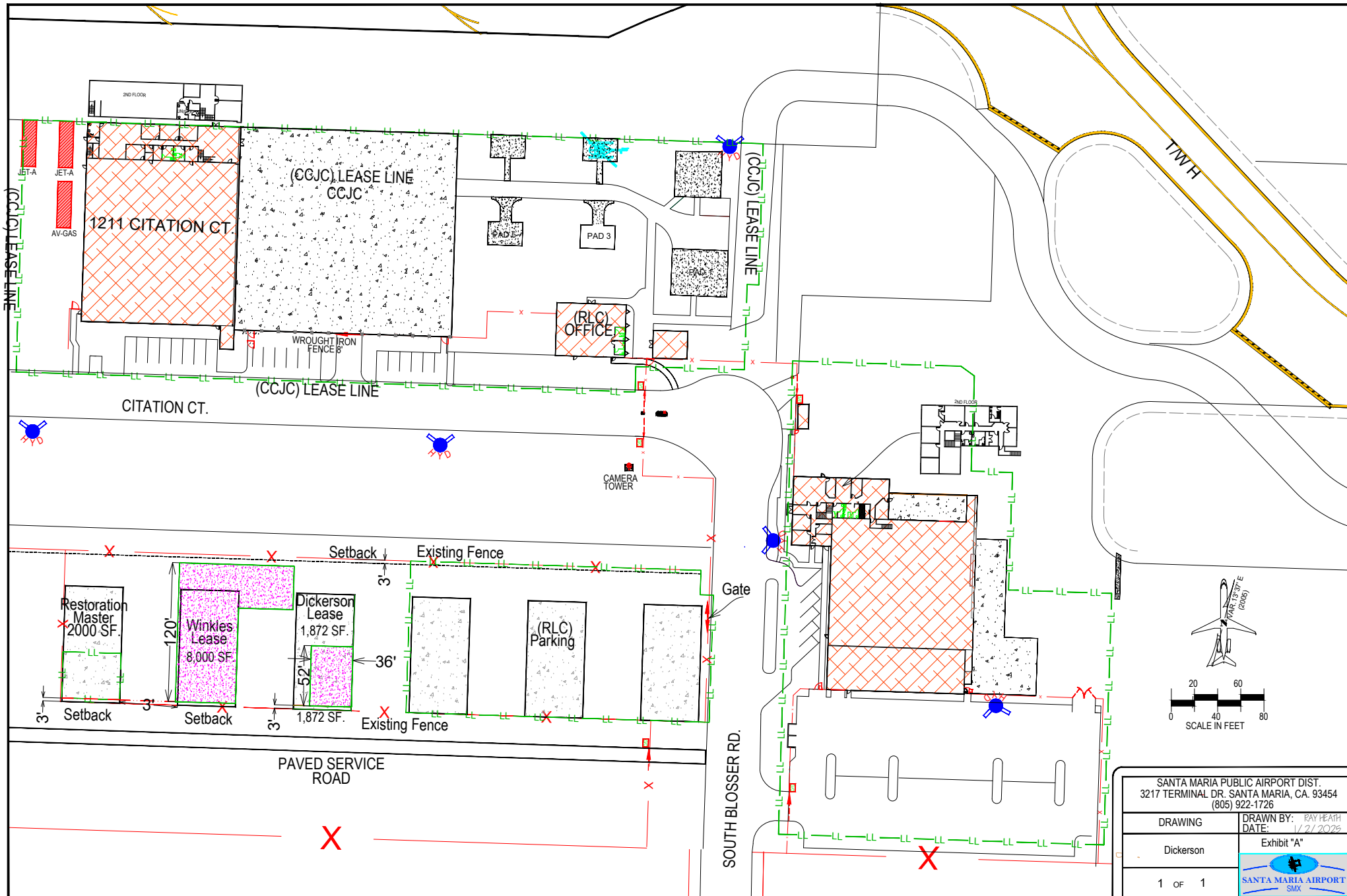

THIRD AMENDMENT TO OPTION AND LEASE AGREEMENT

THIS THIRD AMENDMENT TO OPTION AND LEASE AGREEMENT ("**Third Amendment**") dated as of the later date below (**the "Effective Date"**) is by and between Santa Maria Public Airport District, having a mailing address at 3217 Terminal Drive, Santa Maria, CA 93455 (hereinafter referred to as "**District**") and New Cingular Wireless PCS, LLC, a Delaware limited liability company, successor in interest to Santa Barbara Cellular Systems, Ltd., having a mailing address at 1025 Lenox Park, Boulevard NE, 3rd Floor, Atlanta, GA 30319 (hereinafter referred to as "**Tenant**").

WHEREAS, District and Tenant (or its predecessor-in-interest) entered into an Option and Lease Agreement dated July 27, 2000, as amended by a First Amendment of Option and Lease Agreement dated October 1, 2010, and as further amended by a Second Amendment of Option and Lease Agreement dated February 21, 2020 whereby District leased to Tenant certain Premises, therein described, that are a portion of the Building, known as the Main Hangar, at the Airport located at 3203 Lightning Street, Santa Maria, CA 93455 (hereinafter, collectively referred to as the "**Agreement**"); and

WHEREAS, District and Tenant, in their mutual interest, wish to amend the Agreement as set forth below.

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, District and Tenant agree as follows:

1. **New Premises Area.** District agrees to increase the size of the Premises leased to Tenant to accommodate Tenant's needs. Upon the execution of this Third Amendment to Option and Lease Agreement, District leases to Tenant the additional premises described on attached Exhibit 2 ("**New Premises Area**"). District's execution of this Third Amendment to Option and Lease Agreement will signify District's approval of Exhibit 2. The Premises under the Agreement prior to this Third Amendment to Option and Lease Agreement in addition to the New Premises Area under this Third Amendment to Option and Lease Agreement shall be the Premises under the Agreement.
2. **Generator.** Tenant shall have the right to install, repair, maintain, modify, replace, remove, utilize and operate (including but not limited to operate as may be required by applicable law) equipment within the New Premises Area, including without limitation a concrete pad and generator thereon, including back-up power supply. Tenant shall have the right to access the New Premises Area, and any provisions in the Agreement governing access shall apply to such access. The generator shall remain the property of Tenant, and Tenant shall have the right to remove or modify it at any time.

3. **Rent.** Commencing the first day of the month following commencement of installation within the New Premises Area (“Increase Commencement Date”), Rent shall be increased by Five Hundred and No/100 Dollars (\$500.00) per month, subject to further adjustments, if any, as provided in the Agreement; provided that the first such increased payment shall not be due until sixty (60) days after such commencement date and provided further that, any partial month occurring after the Increase Commencement Date, the increased Rent amount shall be pro-rated.
4. **Other.** District represents and warrants that, to its knowledge, no conditions exist within the New Premises Area or otherwise on the property where the Premises and New Premises Area are located that would adversely impact Tenant’s permitting and/or installation of a generator within the New Premises Area. District authorizes Tenant to prepare, execute and file all required applications to obtain any government approvals for Tenant’s use of the New Premises Area under this Agreement and agrees, at Tenant’s request, to reasonably assist Tenant with such applications and with obtaining and maintaining the government approvals. Where applicable law governs how the generator will be used, Tenant may use the generator in the manner set forth in applicable law. Tenant may terminate this Third Amendment to Option and Lease Agreement by written notice to District at any time, and the rent increase set forth in Section 3 shall not take effect or shall be cancelled, as applicable, following any such termination. Within one hundred twenty 120 days after termination of this Third Amendment to Option and Lease Agreement, Tenant shall remove its equipment from the New Premises Area; provided that any portions of the equipment that Tenant fails to remove within such period and cessation of Tenant’s operations at the New Premises Area shall be deemed abandoned. Tenant shall repair any damage, less ordinary wear and tear, to the New Premises Area caused by its removal activities.
5. **Capitalized Terms.** All capitalized terms used but not defined herein shall have the same meanings as defined in the Agreement.

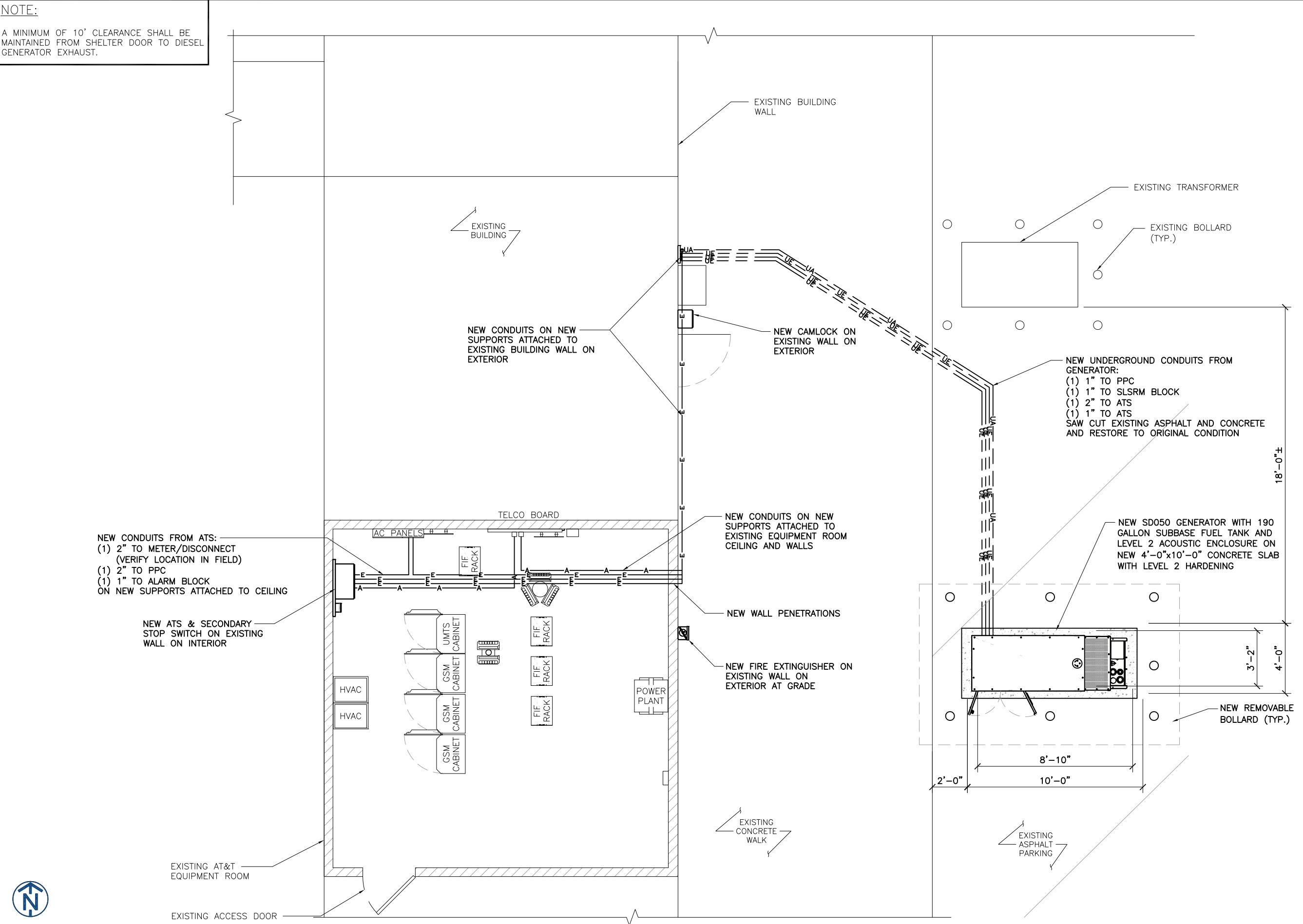
